

Professional Designer Rewards Program Terms and Conditions

Professional Designer Rewards Program discounts are based on a trade eligibility system, beginning at the time of enrollment. The 10% Designer Rewards discount may be applied to any merchandise purchased at a Crate and Barrel store in Canada. Please note, however, that rights are non-transferable and cannot be redeemed at Crate and Barrel, CB2 or Land of Nod stores in the United States, or at crateandbarrel.com, cb2.com or landofnod.com.

Terms of Eligibility:

- Accredited Designers, Architects and Interior Decorators (who are referenced generically in this Letter of Agreement as "Designers" or individually as a "Designer") must present either a business card or letterhead or an identifying letter or membership card from a professional organization.
- The Designer's name and address, or that of his or her Firm, must be listed in the Designer Information at our store.
- The Designer, once approved, is the only person authorized to make purchases and must present his or her Crate and Barrel Designer ID Card along with an accepted form of picture identification (e.g., driver's license, provincial identification card or passport).
- The Designer must sign this Letter of Agreement.

Discount:

- The Designer Rewards discount will be applied at the point of sale. The discount will be applied only to merchandise and not to fees for extra services or delivery, or any other additional fees or costs. The discount does not apply to purchases made prior to enrollment in this program.
- To request a Designer Rewards discount at the point of sale, a designer must present his or her Crate and Barrel Designer ID Card along with an accepted form of picture identification. Designers must use their own credit cards; credit cards of a Designer's clients will not be accepted.
- All qualifying purchases must be made by the Designer in person only at a Crate and Barrel store in Canada. Phone orders and orders by any other person are not accepted.
- Merchandise eligible for the Designer Rewards discount is limited to merchandise that is available in Canada, including full-price, reduced-price and closeout items. Merchandise from US Crate and Barrel, CB2 or Land of Nod stores, crateandbarrel.com, cb2.com and landofnod.com, including merchandise sold only in the United States or through other channels (other than through our stores in Canada), is not eligible for Designer Rewards or for the attendant discount.
- All merchandise eligible for the Designer Rewards discount is priced in Canadian dollars, and the corresponding discount is calculated using Canadian pricing alone. Prices for merchandise are set for each item and are non-negotiable.
- Product returns and exchanges are subject to the Crate and Barrel return policy and will be credited at the 10% discount rate.
- Designer will be responsible for payment of any and all taxes due on the discounted amounts, in accordance with any applicable laws or regulations.
- Stores will keep track of a Designer's sales and reserve the right to review and terminate a Designer's eligibility if the Terms of this Agreement are violated.

Crate and Barrel reserves the right to change the terms and conditions on which the Designer Rewards Program is conducted and/or the attendant discount is provided, and to terminate such program and/or discount at any time. Such changes or termination may occur at the discretion of Crate and Barrel, even without prior notice to Designer.
